A YEAR IN REVIEW

2020 presented many challenges but thanks to generous supporters and committed staff and board members, Adriel was able to adapt to continue to meet the needs of children and families in our community. Over the past few years, Adriel has been committed to upgrading our technology systems. Because of the progress made, Adriel was able to pivot our services to meet the needs of our clients while also keeping staff, clients, and consumers safe and healthy. In the latter half of the fiscal year, Adriel staff began working from home as often as possible; began utilizing telehealth to provide therapy services to youth over video conferences to insure that they receive the emotional and mental health support they need; and converted pre-service and in-service trainings to live, interactive, online classes. Continuation of training ensured that all licensed homes maintained their status and allowed Adriel to continue to license new homes and accept new placements of foster youth. We are so grateful for the support of individual donors and local churches, businesses, and organizations that have allowed Adriel to thrive even during this time of uncertainty.

In Fiscal Year 2020...


- Adriel served **353** youth and **24** young adults.




*Examples of 'other' revenues include: training, grants, & rentals
