In Fiscal Year 2022...

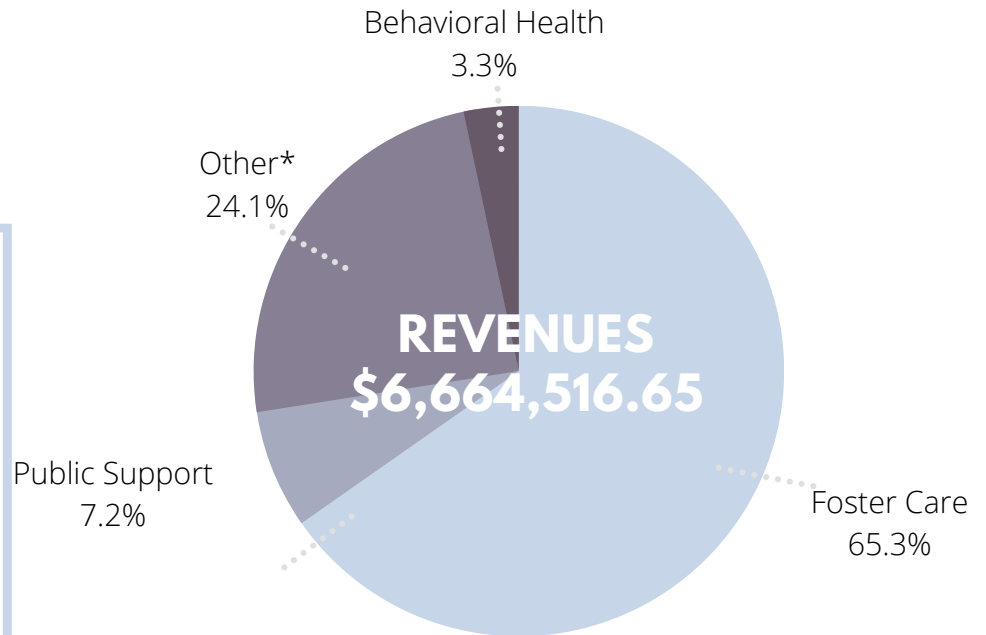
- ☑ Adriel served **332** youth through foster care and licensed **37** new foster homes.

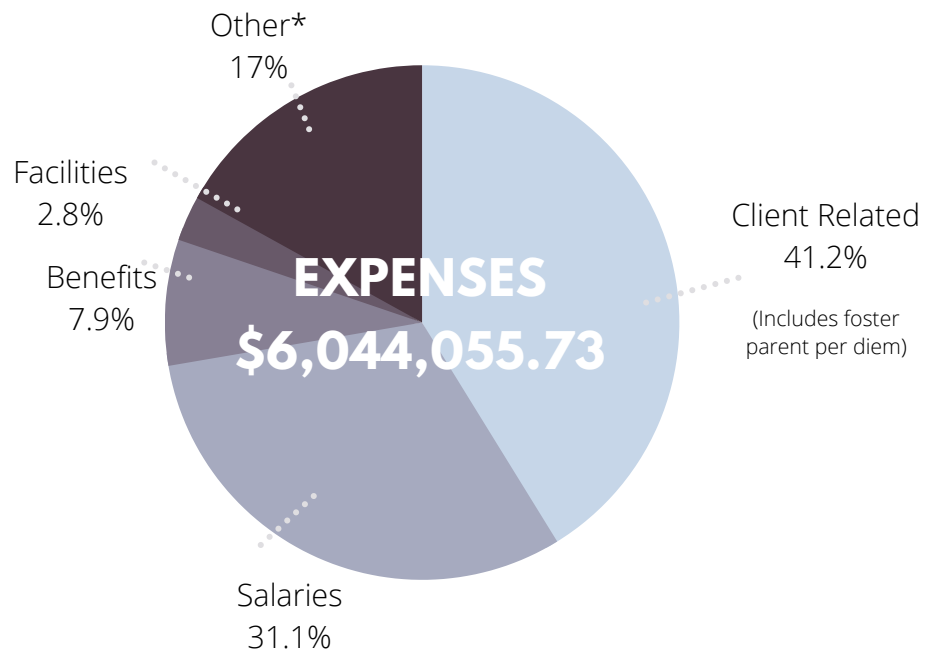
