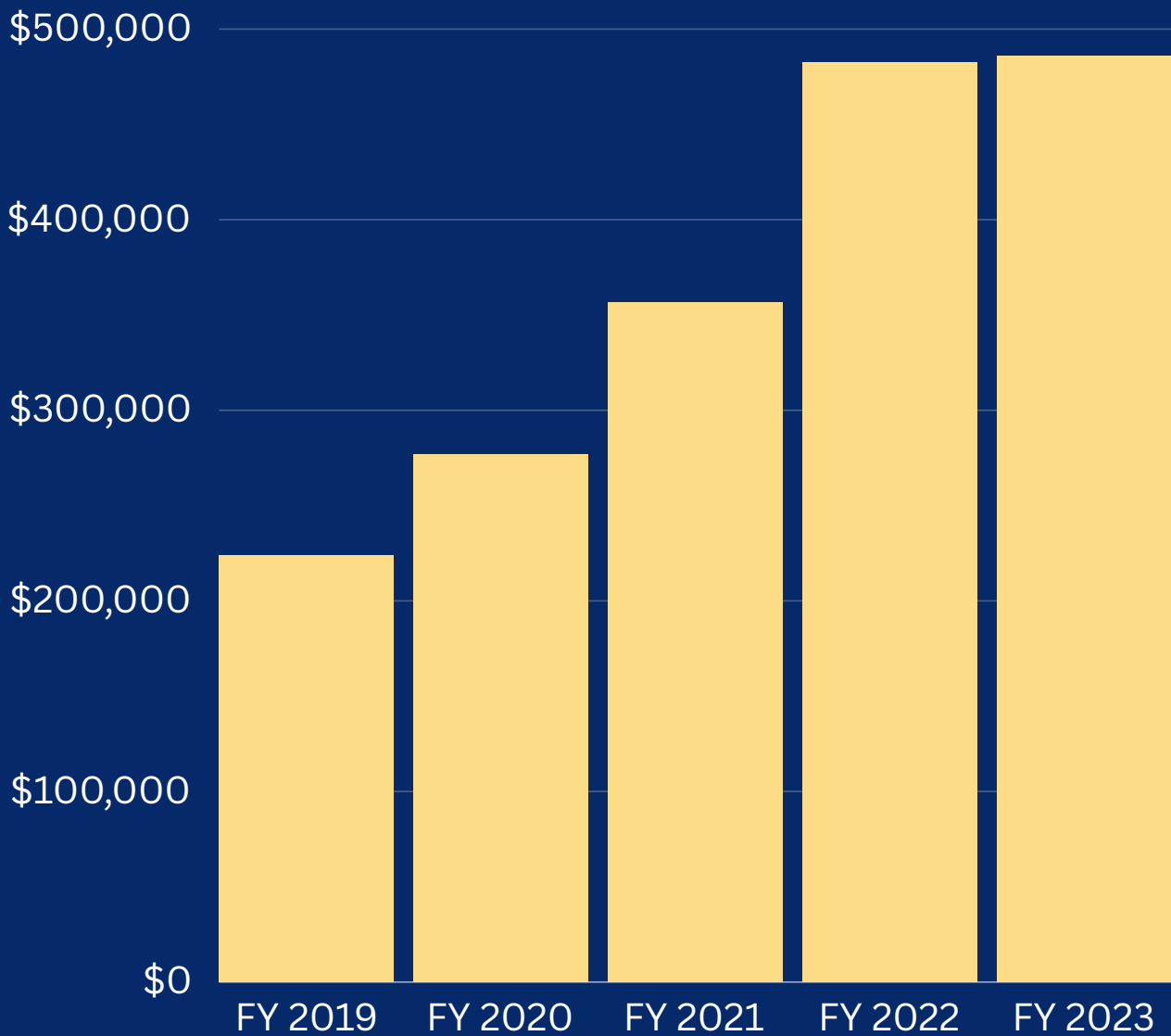

31 were adopted by their Adriel foster family.

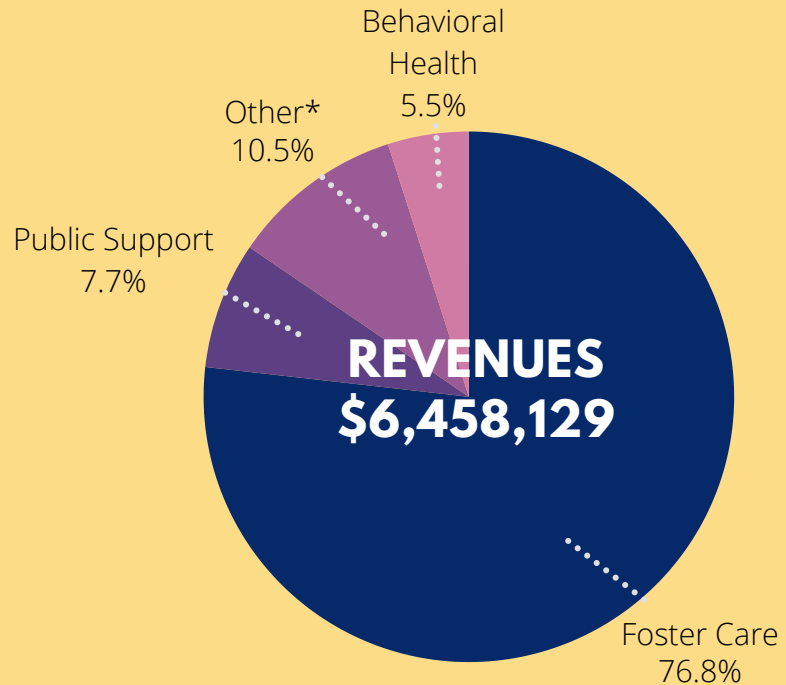
Over **225** donors gave **\$486,186**

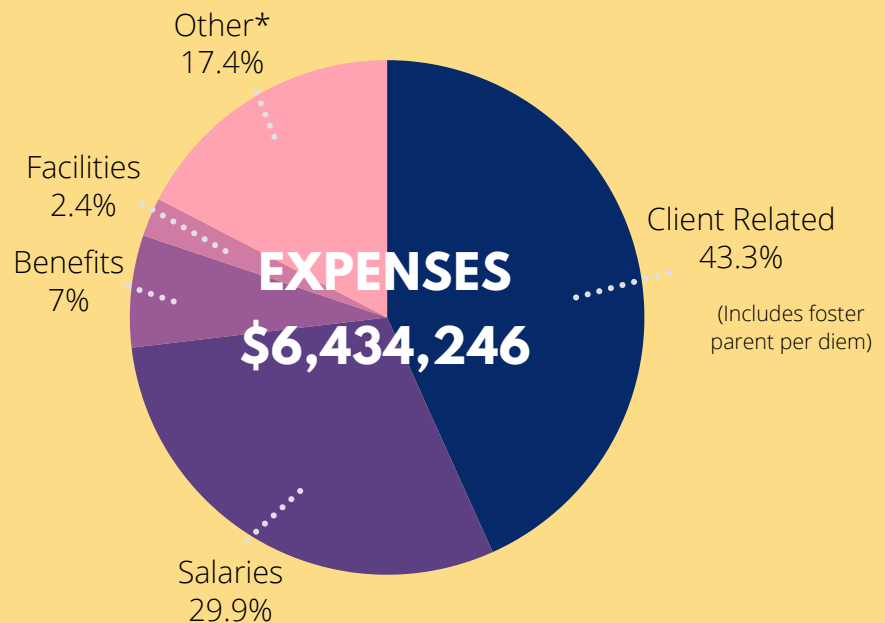
