Teaching Family Model Campaign

One of the primary ways that Adriel provides tools and resources for foster parents to work with children is through the use of the Teaching Family Model (TFM). The Teaching Family Model was developed using scientifically proven methods of behaviorism and provides effective, individualized services to children and families.

Each of Adriel's foster families have the opportunity to achieve certification in the Teaching Family Model. This process consists of conferences, training, and assessments. Currently, 38 of Adriel's foster families are certified in this model. Adriel's long term goal is to provide all of our foster families with the resources to achieve this certification - and we need your help to get there!

Adriel receives no additional funding or grants for this process. The TFM is such an important part of our work that the funds required come directly out of Adriel's expenses. The cost to support each family in all aspects of the Teaching Family Model is approximately \$1000. We are requesting your help to sponsor as many families as you are able - currently Adriel has around 200 foster homes.

For each \$1000 donated, you are providing the tools needed to help a foster family receive their TFM credentials and continue their development in the model. You are helping prepare this family to succeed with each foster placement that is brought into their home. You are providing the tools and resources necessary to make an impact on those children that are expected to come into care.


